II. TRAVEL

Travel Fee: \$100

Mileage - Anything round-trip over 15 miles from BLB Luxury Studio (2255 Fifth Ave N. Saint Petersburg, FL 33713) will be charged \$1.00/mile.

A \$100 travel fee applies for on-location services. Mileage is charged at \$1.00/mile round-trip beyond 15 miles from 2255 Fifth Ave N. Saint Petersburg, FL 33713. Any applicable parking, valet, or toll fees must be covered by the client. Early start times (before 8:00am) will require hotel accommodation for the artist.

III. RETAINER & PAYMENTS

To secure your wedding date, a signed bridal contract and a \$50 deposit are required. This deposit is non-refundable and non-transferable. The deposit and signed contract are required to reserve your wedding date. Dates are not held without both. The remaining balance is due on or before the wedding day prior to the artist's departure. Accepted payment methods: Cash, Venmo, or Apple Pay.

IV. DELAYS

A late fee of \$25 will be charged for every 30 minutes of delay when a client is late for the scheduled time, or if the scheduled makeup application exceeds the allotted time due to client delays.

V. CANCELLATION POLICY

Cancellations within 30 days of the event date will be charged 50% of the total balance. No shows or same day cancellations are charged in full. In the unlikely event that the artist cannot fulfill the booking due to illness or emergency, deposit will be refunded and a replacement artist will be recommended if possible.

VI. ARTIST POLICIES & TIMING

Please arrive on time with a clean, makeup-free face. Each makeup service typically takes between 35-45 minutes per person. If your wedding venue does not allow early access or sufficient time for the getting ready process, I highly recommend booking a nearby Airbnb or hotel suite for your bridal party to get ready comfortably and without stress. This helps insure everyone is relaxed, not rushed and the schedule runs smoothly for both makeup and bridal party. If the bridal party size or timeline requires a second artist, additional artist fees will be discussed and added to the total balance.

VII. LIABILITY & HYGIENE

All brushes, tools, and makeup products are sanitized upon arrival and in between each makeup application. Makeup products used are hypoallergenic mineral based products. Any allergies and/or skin conditions should be reported by the client to the makeup artist prior to application. Clients agree to release the makeup artist (Emily Williams) from liability for any skin complications due to allergic reactions. Once services are completed the artist is not responsible for any makeup products, belongings, or damages that may occur at the venue or on-site location. Clients are responsible for insuring a clean, safe, and stable setup area for all beauty services.

VIII. PHOTOGRAPHY & SOCIAL MEDIA

Photos and videos may be taken for promotional use and advertising purposes. By signing this contract, the client grants permission for images or videos taken before, during, or after makeup application to be used on social media, marketing, or portfolio platforms. The client will also be tagged when applicable and represented respectfully. Full credit will be given to any professional photos or videos taken by photographers and videographers.

Final headcount is due when contract is signed. Any reduction in services after that date will be subject to full payment. Your final timeline will be customized 30 days prior to your wedding day after coordinating with your planner to give you a seamless getting-ready experience.
